

ABSENTEE VOTING IN MUSKINGUM COUNTY, OHIO

SPECIAL ELECTION- August 7, 2018

OPTION 1: VOTE BY MAIL

PROCESS:

Step 1: Print Application for Absentee Voter's Ballot [below](#).

*(*please see an important note about completing your application below).*

Step 2: Mail completed Application for Absentee Voter's Ballot to Muskingum County Board of Elections (627 Market St, Zanesville, OH 43701). To avoid delays- be sure to include date of birth, one form of ID, and signature on application in appropriate places. Application for Absent Voter's Ballot must be received no later than **August 4, 2018**.

Step 3: Upon receiving your completed application, Muskingum County Board of Elections will mail your ballot to address indicated on application, beginning **July 10, 2018**.

Step 4: Instructions for voting and returning your ballot will be included in the envelope you receive.

Once your ballot is voted- return by mail to the Board of Elections. Return envelopes must be postmarked by **August 6, 2018**.

***Please note:** Voted ballots August also be returned in person to the Board of Elections office and must be received by **7:30 pm on August 7, 2018**.

OPTION 2: VOTE EARLY IN-OFFICE

Beginning **July 10, 2018**, in-office Absentee voting is available at the Muskingum County Board of Elections office (627 Market St, Zanesville). Please have driver's license, state ID, or utility bill ready to present for identification. In-office voting is available during the following hours:

8:00 a.m. to 5:00 p.m. – Tuesday, July 10 thru Friday, July 13
8:00 a.m. to 5:00 p.m. – Monday, July 16 thru Friday, July 20
8:00 a.m. to 5:00 p.m. – Monday, July 23 thru Friday, July 27
8:00 a.m. to 7:00 p.m. – Monday, July 30 thru Friday, August 3
8:00 a.m. to 4:00 p.m. – Saturday, August 4
1:00 p.m. to 5:00 p.m. – Sunday, August 5
8:00 a.m. to 2:00 p.m. – Monday, August 6

****In-office early voting is available with our new paper method!****

- Ballot can be voted same day or taken home by voter.
- Only the voter present may request a ballot. **YOU MAY NOT REQUEST OR CARRY ABSENTEE BALLOTS FOR OTHER VOTERS, INCLUDING THOSE IN YOUR HOUSEHOLD.**
- Voter completes and signs Absentee Application and Identification Envelope (application can be printed and filled in by voter prior to arriving at office).
- Voted ballots must be received by the Board of Elections office by **7:30 pm on August 7, 2018**.

If you are unable to locate your voter registration information but think you are registered to vote and you have not moved outside of your county of prior registration, you August be eligible to cast a provisional ballot during in-person absentee voting period at an appropriate early voting location or the county board of elections, or on Election Day at the correct polling place for your current address that August be counted.
